Subject:- Grant of Dearness Relief to Industrial Dearness Allowance (IDA) Pensioners/ Family Pensioners of the FCI at the modified rates with effect from 01.01.2007 and thereafter.

Sub: - Grant of Dearness Relief to Industrial Dearness Allowance (IDA) Pensioners / family pensioners of the FCI at the modified rates with effect from 01.01.2007 and thereafter.

Sir,

I am directed to refer to this Department's letters No. 38020/1/2009-FC.3 dated 25-10-2010 and 1-11-2010 (copies enclosed) and to state that IDA pensioners/ family pensioners covered under the instructions contained in these letters have become entitled for payment of Dearness Relief (IDA) at the rates revised by the Department of Public Enterprises with effect from 01.01.2007 as per O.M. No. 2/70/08DPE(WC)/GL-XVI dated 26-11-2008 as Dearness Relief granted to them as on 1.1.2007 will become zero with link point of All India Consumer Price Index (AICPI) 2001=100 which was 126.33 as on 1.1.2007. Accordingly, approval of the Government of India is conveyed for the payment of Dearness Relief to these IDA pensioners/family pensioners at the following rates:-

Sub: - Revision/ Rationalisation/ Consolidation of pension/family pension of Post December, 1988 and Pre January 2007 retired Category I & II and Post July 1987 and Pre January 2007 retired Category III & IV employees (Food transferees) of the Food Corporation of India on the IDA scales of pay consequent upon revision of the scales of pay by w.e.f. 01.01.2007.

Sir,

I am directed to refer to the letters No. WRC/39/2/2009 dated 12.10.2009 and 26.4.2010 of the FCI on the above mentioned subject and to say that the pay and allowances of the Category I, II, III & IV employees of FCI governed by the Industrial Dearness Allowance (IDA) pattern pay scales have been revised vide this Department's order No. 16-2/2008.FC-I dated 18.09.2009 and 16-1/2006.FC.I (Vol.III) dated 30.3.2010.

2. The earlier instructions issued by this Department vide letter No. 38020/1/2000-FC-3 dated 31.5.2005 regarding revision/rationalization/ Consolidation of pension/family pension w.e.f. 1.1.1997 of the pensioners who retired on IDA scales (Food Transferees) was based on the general guidelines issued by the Department of Pension and Pensioners Welfare vide their O.M. No. 4/14/2001-P&PW(D) dated 19.9.2003. The Department of Pension and Pensioners Welfare have also issued the general guidelines for revision of pension of pre-2006 pensioners / family pensioners etc. vide their O.M. No. 38/37/08-P&PW (A) dated 1.9.2008 in connection with the recommendation of the VIth Pay Commission.

3. With reference to this Department's letter No. 38020/1/2000.FC.3 dated 31-5-2005, I am directed to state the following:-

It has become necessary to revise/rationalise/consolidate pension/family pension of Post December, 1988 and Pre January 2007 retired Category I & II post July 1987 and pre-January 2007 retired Category III & IV employees of the FCI also. The matter has been considered in consultation with the **integrated Finance Division of this Department and the Department of Pension and Pensioners' Welfare** and it has been decided to regulate, **w.e.f. 01.01.2007**, the pension/family pension of all such IDA pensioners/family pensioners in the manner indicated in the succeeding paras.

- 4. In these orders:-
 - (a) 'Existing Pensioners' or 'Existing Family Pensioner' means a pensioner who was drawing/entitled to pension/family pension on 30.12.2006
 - (b) 'Existing pension' means the basic pension, inclusive of commuted portion, if any, due on 31.12.2006. it covers all classes of pension under the CCS(Pension) Rules, 1972 as also disability pension under the CCS(Extra Ordinary Pension) Rules.
 - (c) 'Existing Family Pension' means the basic family pension drawn on 31.12.2006 under the CCS(Pension) Rules, 1972.
 - (d) 'Existing Dearness Relief' means the ACTUAL relief due to pensioners/family pensioners upto AICP Index Average level 2884 (which is 126.33 point All India Consumer Price Index (AICPI) 2001=100 series)

5. The pension/family pension of existing post December, 1988 and Pre January 2007 Category I & II and post July, 1987 and pre-January, 2007 Category III & IV pensioners/family pensioners will be consolidated w.e.f. 01.01.07 by adding together:-

- i) The existing pension/family pension,
- ii) **ACTUAL** Dearness Relief due upto AICP Index Average level 2884 – 78.2% (it includes effect of merger of 50% Dearness Relief with pension/family pension plus Dearness Relief,
- iii) Fitment weightage @ 30% of the existing pension/family pension.

The amount so arrived at will be regarded as consolidated pension/family pension w.e.f. 01.01.2007 subject to minimum/maximum limit prescribed under the CCS(Pension) Rules, 1972. Since the consolidated pension will be inclusive of commuted portion of pension, if any, the commuted pension will be deducted from the said amount while making monthly disbursements.

6. Since the consolidated pension/family pension arrived at as per paragraph 5 includes Dearness Relief upto AICP Index Average level 2884, (which is 126.33 point All India Consumer Price Index(AICPI)2001=100 series) Dearness Relief will be admissible thereon **only beyond this index Average level 2884** in accordance with the revised scheme of Dearness Relief for which orders are being issued separately by this Department on an authorization by the Department of Public Enterprises.

7. The consolidated pension/family pension as worked out in accordance with the provisions of para 5 above shall be treated **as final 'Basic Pension' w.e.f. 01.01.2007** and shall qualify for grant of Dearness relief sanctioned thereafter by the Deptt. of Public Enterprises or this Department on their authorization in respect of following categories of pensioners/family pensioners:

- i) Category I & II Pensioners who retired between the period 01.01.1989 and 31.12.2006 and Category III & IV pensioners who retired between the period 01.08.1987 and 31.12.2006.
- Family pensioners, who became entitled for family pension during the period from 01.01.89 to 31.12.2006 (Category I &II) and 01.08.1987 to 31.12.2006 (Category III & IV) and were sanctioned family pension at the percentage prescribed in the CCS (Pension) Rules, 1972 of the last pay drawn by the deceased employee.
