Kindly refer to my earlier letter dated 4.1.2022 on the above subject matter, wherein it has been brought to your kind notice that, the orders mentioned under reference are not being honoured by some empanelled hospitals, e.g. Fortis Hospital, Jaipur, Rajasthan and still CGHS counter staff of Fortis Hospital, Jaipur is asking for referred letter from CGHS medical Officer for the investigations advised by the specialists of the empanelled hospitals in respect of CGHS beneficiaries aged 75 years and above. Thus, the CGHS beneficiaries aged 75 years and above are compelled every time to go to the CGHS medical officer for referral.

In this regard; it is understood from the Nodal Officer of Fortis Hospital, Jaipur that, they have instruction from Additional Director, CGHS, Jaipur to not adhere to the instructions contained in the orders cited above.

It is needless to state that it is the clear violation of the above referred orders by the authorities of Fortis Hospital, Jaipur, Rajasthan.

In view of the above, it is therefore requested to kindly intervene in the matter and issue necessary instructions to Fortis Hospital, Jaipur, Rajasthan for the true implementation of the above referred letters issued from your good office.
