We would like to draw your kind attention towards the pay fixation case of Officiating JTOs under FR 22(1)a(i).					
In this connection vide order under reference No.1- Corporate office had issued orders to all CGM on 28.08.2020 for pay fixation methodology of departmental. JAOs.					
Vide order under reference No.2- Corporate had issued order to CGM Kerala Telecom Circle on 27.10.2020 for pay fixation methodology of JTO (Offtg) on the same formula basis like that of departmental JAO issued vide reference No.1.					
Vide order under reference No-3-Corporate had issued order to CGM Kolkata Telephones issued orders on 19.07.2021 for the pay fixation of JTO (officiating) on the same formula basis like that of departmental JAO issued vide reference No.1					
While the order under reference no.1 was issued to all the CGMs, the orders under referece No.2 and 3 had been issued to CGM Kerala and CGM Kolkata Telephone only and no copies are marked to any other Circle heads. Whereas the formula applied in all the three orders are same.					
It is, therefore, requested that the order dated 28.8.2020 issued in the case of JAOs to all CGMs may kindly be reissued by Corporate office to all CGMs, for both the cadres of JAOs and JTOs (Dept) for their pay fixation to avoid discrimination amongst the cadres.
