Subject: Medical facility for pensioners.

Respected Madam,

BSNL CO has issued two orders vide BSNL/Admn.i/15-12/18 dated 11 th July,2018 and BSNL/Admn.i/15-22/14 dated 13 th July,2018 clarifying the revised ceiling limit for with and without voucher claims effective from 1-4-2018. According to these orders for calculating the limit the 78.2% IDA merged basic at the time of retirement has to be considered. But nothing is mentioned about the pensioners who retired before 1-1-2007 and 78.2% IDA was merged with their pension not with Basic. There are some other points also needs clarification as below.

1) Whether the provisions of the order BSNL/Admn.i/14-2/09 dated 8 th Sept,2010 (copy enclosed) is still valid for pensioners retired before 1-1-2007. Otherwise what will be annual limit for the pensioners retired before 1-1-2007 for with and without voucher cases. Kindly keep in mind that these pensioners are very old and in need of more medical attention but their basic pay and IDA at the time of retirement was low compared to those retired after 1-1-2007. Therefore while deciding the annual limit for them due weightage has to be given.

2) What will be last date for exercising option for the current year as the orders issued very late at the end of first quarter.

3) Whether the pensioners who will retire after issue of this order will be allowed to exercise option for without voucher. Last year they were not allowed.

Kindly issue the clarification on above points early for the benefit of the pensioners.
