Sub: Denial of Pension Revision to BSNL IDA pensioners drawing
pension as per CCS (Pension) Rules 1972 from consolidated fund of
Govt. of India

Respected Sir,

We the Pensioners and Family Pensioners of BSNL who were DoT employees and permanently absorbed in BSNL with the commitment that "It has been decided by the Government that the employees of DoT who will be absorbed in Bharat Sanchar Nigam Limited (BSNL) will be entitled to Govt scheme of pension/family pension even after their absorption in BSNL" are now being denied pension revision by DoT on the following grounds :


- 1) CPC recommendations on pension revision are not for BSNL IDA pensioners
- 2) Pension Revision of BSNL Pensioners will be only after pay revision of BSNL employees as per 3rd PRC report.

Detailed statuses of BSNL Pensioners/Family Pensioners are described in the attached note and table. Although most of the recommendations of CPCs are implemented for us, pension revision and minimum pension are not being implemented as we are IDA pensioners. Moreover our pension Revision is being linked with pay revision of BSNL employees which is dependant on profitability of BSNL. Our pension is paid by Govt of India and BSNL has no role in it. Further during our service period, full pension contribution is paid to DoT corresponding to the maximum of the scale.

We humbly request you to extend your helping hand to these helpless pensioners and family pensioners. We are sure that if the issue is taken up by your good office, the pensioners and family pensioners will certainly get the justice being denied by the Department of Telecommunications(DoT)
