Sub.: Provision of Mobile connection to retired / retiring BSNL employees in view of closure of WLL services- request for implementation.

Ref:- BSNL CO letter no. 2-7/2007-PHA dated 20.07.2007. Circular No. 11/200-PHA.

Respected Sir,

In the above cited reference and subject matter, it is bring to your kind notice that BSNL Corporate Office has already issued orders regarding provision of Mobile connection to retired /retiring BSNL employees in view of closure of WLL services but many Telecom Circles has not implemented this BSNL CO orders and the BSNL retired /retiring employees are finding difficulty. This facility was provided to those employees who are not provided landline facility due to non feasibility or availing existing WLL connection may be provided Prepaid Mobile facility on monthly recharge basis as per Corporate Circular no. 11/2007-PHA”.

As per Circular no. 11/2007-PHA		Approved

Salient features:-

1. Free SIM in lieu of rent free connections.
2. C-Top UP of the value equivalent to free local calls. C-TOP UP may also provided on existing BSNL SIM in the name of the employees.
3. Employees has to give undertaking that he is not availing the landline connection.
4. All others guidelines as per Circular No. 11/2007-PHA have to be followed.
5. This facility is approved for two months from the date of issue of letter.

We would therefore request you to kindly intervene in the matter so that a reminder is further issued to all the Circles to implement the BSNL CO Circle to facilitate the BSNL retired /retiring employees by giving Mobile connection in view of closure of WLL services and the landline telephone connection could not be provided due to non-feasible area.
