Kindly supply me a photocopy of the detailed Cabinet Note circulated vide F.No.16-4/2002-B dated 29<sup>th</sup> October 2004, specifying the liabilities of BSNL and the Government of India towards payment of pension to DoT Retirees as on 1/10/2000 and deemed DoT Retirees absorbed in BSNL as on 1/10/2000. Photocopies of all the Annexures and comments of all the concerned Ministries may kindly be provided.
2. Kindly confirm whether Bharat Sanchar Nigam Limited was consulted before forwarding the Cabinet Note specifying the liabilities of BSNL and the Government of India towards payment of pension to DoT Retirees as on 1/10/2000 and deemed DoT Retirees absorbed in BSNL as on 1/10/2000? If so, the reply/ comments of BSNL regarding Cabinet Note dated 29<sup>th</sup> October 2004 may kindly be furnished.



1. C.M.D., BSNL wrote a DO letter to Secretary(T), Department of Telecommunications vide D.O. No. 500-57/2003-04/CAII/BSNL dated 24<sup>th</sup> February 2005 regarding the liability of BSNL towards payment of Pension to DoT Retirees as on 1/10/2000 and deemed DoT Retirees absorbed in BSNL as on 1/10/2000 and its implications for BSNL. **Kindly supply me a photocopy of the D.O. No. 500-57/2003-04/CAII/BSNL dated 24<sup>th</sup> February 2005 written by CMD, BSNL to Secretary(T), DoT, New Delhi.**

2. Secretary (T) replied to CMD, BSNL's DO letter dated 24/2/2005 vide D.O.No.1-45/2003-B dated 15<sup>th</sup> March 2005, assuring the BSNL that liability of BSNL was limited to payment of Pension Contribution for the DoT Employees absorbed in BSNL as on 1/10/2000 and also for DoT Employees on deemed deputation to BSNL. Pension liability of Employees absorbed in BSNL and those on deemed deputation shall be met by Government of India. **Kindly supply me a photocopy of the D.O.No.1-45/2003-B dated 15<sup>th</sup> March 2005 along with copy of Note Sheets leading to the decisions contained in the OM No.1-45/2003-B dated 15<sup>th</sup> March 2005.**

DDG(FEB) issued a circular vide letter No.1-45/2003-B dated 15<sup>th</sup> June 2006 regarding Pension liability of BSNL towards pensionary benefits including Family Pension to its Employees and also to DOT Pensioners as on 1/10/2000.
