**Sub: Meeting held on 1-8-2017--- follow up actions**

Respected Sir,

Kindly recall the discussions we had in the meeting held on last Tuesday at 11-30 hrs. Where at the begining we have pointed out that in the list uploaded in your website names of only 3568 pensioners are there for whom the pension revision was processed upto 15-06-2017. At which your good office has intimated that the exact figure will be 5200 and the list containing 5200 names have already been uploaded on that morning. Thereafter our discussion continued considering the fact that 5200 cases are completed.

To our utter surprise, when we came back to our home, we find that the same old list of 3568 pensioners is still there in the web side. We waited till today morning for the promised updated list of 5200 pensioners but still it is not there. We are really shocked for such blunt falsification done with the pensioners by your good office and the intension behind such action is only known to your officers but certainly it is to avoid the responsibility to the poor helpless pensioners.

The second point we discussed in the meeting was to trace out the pensioners whose case has not been forwarded by BSNL. In this aspect we could trace a list of 2733 pensioners retired from WBTC from 1-1-2000 to 31-3-2010. This list we have matched with the list of 3568 pensioners uploaded in your site. This matched file PENSION\_COMPARED .xls is attached herewith in your email. After matching, two columns are added in the original file. First one is MARK(Column B) where 'Y' is added against the records which is totally matched, 'X' is added against the record where Name and Surname matched without Middle Name and 'Z' is added in the records which are manually checked after above two matching. The records against which there is blank in MARK column could not be traced in the uploaded file. In the next Column C (REF SL NO), serial no of the records of uploaded file which are matched is mentioned.

Kindly arrange to check the unmatched records. As PPO number and file numbers are mentioned, it will be easier to find out whether 78.2% work is completed for these pensioners or not. The original list of 2733 pensioners and the uploaded list are placed at sheet 2 and 3 of the attached file for your perusal.


The list we could trace contains 2733 name who retired upto March 2010. The 78.2 revision has to be done for pensioners retired upto June 2013. During this period retirement rate was more and at least there will be another 2200 pensioners who retired during this 39 months. Hence total pensioners of WBTC before June 2013 will be around 5000. With this pensioners of ETR, ETP, TS, TF also to be added. There fore by all probability the total figure 6393 as mentioned in DOT's list is the correct figure of the West Bengal Pensioners for whom 78.2% pension revision has to be carried out.

As the discussion we had on 01-08-2017 was based on incorrect figures and information, the actual problem and ways and means to overcome it was also could not be discussed properly. Also in the meeting your good self has assured to send some notifications of your office and some names of family pensioners to our email. But we have not received the mail yet.

**We therefore request you to arrange for one more round of discussion in the next week.** Kindly realise that the issue of extending the 78.2% pension revision to the entire eligible pensioner are far more pending than the reports given to you. We hope that you shall allow us to discuss the issue for the benefit of poor helpless pensioners. As assured we are ready to extend any kind of help to resolve the issue.
