Sub: Issues being faced by BSNL pensioners of CTD Circle.

Respected Sir,

We would like to bring to your kind attention on the few issues being faced pensioners of CTD circles as stated under

- 1. Payment of rest 8% of ex gratia is still pending. DOT has instructed to clear ex gratia payment several times, WB Circle is on the process, but in very little attention is given in CTD.
- 2. Group Insurance payment is badly affected. Some retirees of 2018 even did not get insurance payment. For some executives in Howrah (& SMP) division also did not get this payment, as documents have not yet been sent to the concerned office.
- 3. TDS has been deducted from the ex gratia amount already paid, but not sent to Income Tax department, for which we have to pay penalty in the last F.Y. for which the employer is solely responsible.
- 4. After approval of CGHS Reimbursement cases, SAP entry is not done for which many cases are pending for a long time.

In all the cases CTD is seen very reluctant to settle the financial matters of the VRS Optees.

Therefore you are requested to kindly look into the matter personally and arrange to instruct concern officers of CTD to do the needful action at the earliest.

Your kind favour will be a great help for pensioners of CTD..
