Subject: Formation of PR (Pensioners Relation) cell in BSNL.

Dear Sir,

At present the number of BSNL pensioners are about 2 lakhs as compared to serving employees of similar number. The medical facilities to these pensioners are extended by BSNL as per BSNL MRS Provisions. Also the Service Books of these pensioners are kept in BSNL's custody and for any pension related jobs BSNL has to issue sanction memo to the CCA units for further action. In nutshell following are the responsibilities being carried out by BSNL for its pensioners.

- Reimbursement of Medical Bills (Indoor + Outdoor)
- Medical claims for without voucher cases
- Issuing sanction memos for pension revision
- Issuing sanction memos for all other pensionery benefits. Etc.

It is observed that Pensioners are facing lot of difficulties in settlement of above issues in field. Unfortunately as at present there is no designated officer for the welfare of pensioners either in corporate level or in circle level. We therefore request you to kindly examine the issue and officially entrust the job of PR (pensioners relation) to some PGM ranking officer both corporate and circle level.

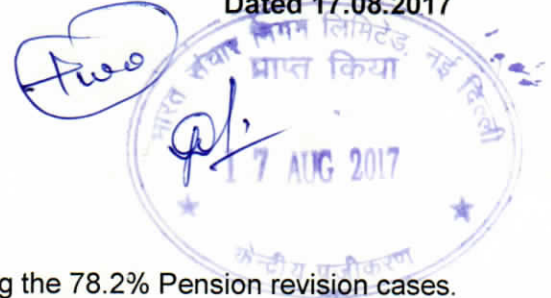

Subject: Abnormal delay in settling the 78.2% Pension revision cases.

Dear Sir,

Kindly find enclosed herewith a status report issued by DOT finance wing on 78.2% pension revision cases as on 31st July 2017 i.e. after one year of the issue of the order. Kindly note that as per the report BSNL circles are yet to send 7675 Service Books to respective CCAs. Also 2196 cases have been referred back to BSNL for wrong calculation etc. That means as per DOT, pension revision cases for about 10,000 pensioners are pending for BSNL. It may also be noted that out of 26 CCAs only 5 CCAs are having some pending cases, remaining have no cases pending with them.

In fields we are experiencing different situation. In the circles where it is mentioned as no pending cases, are actually having many pending cases with them. But the main problem is regarding the figure mentioned as pending with BSNL. This has to be reconciled between the circles and CCAs to identify the cases. For example the figure for Kolkata Phones is shown as 1279 which is pending with BSNL. But the management of CTD is not accepting this figure. According to them maximum 100 cases are pending. Same is the position of other circles. Therefore it is absolutely necessary that reconciliation of these pending cases is done between BSNL and DOT to identify the cases. The most unfortunate point is neither BSNL circles nor CCAs are having any comprehensive list and details of pensioners in most of the circles. As a result they are unable to locate the pensioners whose pension is not revised.

We therefore request you to kindly issue necessary instructions to all circles, so that the pensioners whose pension is not revised are identified and their details may be circulated in respective websites for information of all
