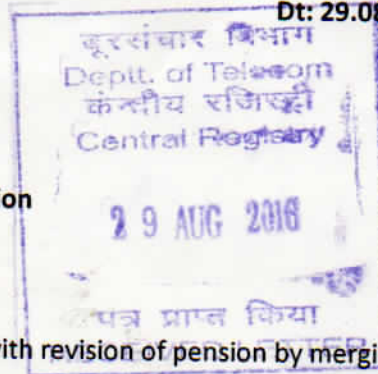

Sub: Linking of ADHAR NO etc with revision of pension by merging 78.2% IDA --  
Request to delink

Dear Sir,

We are bringing to your kind notice that CCA West Bengal vide his letter no CCA/WBC/PEN/CORR/BSNL/16-17 dated 16-08-2016 has linked ADHAR NO for revision of pension by merging 78.2% IDA from 1-1-2007 work, although DOT in its order No. 40-13/2003-Pen(T) dt 18-07-2016 has not mentioned any such linking. In both the proformas related to pre and post 2007 pensioners they have mentioned ADHAR No as mandatory field and also PAN NO and Contact No.

In this contexts we would like to point out that:

- ADHAR work is yet to be completed in INDIA and like other citizens, all Pensioners do not have the card
- BSNL offices at the time of retirement has not collected this information from the officials as these items were never part of the pension papers.
- Many pensioners particularly of GR D cadre, go to their native places, which are far away from the offices they worked. Hence now it will be impossible to collect this information from them. Same difficulty will be with the family pensioners.

We therefore request you to look into the matter and to take necessary action so that collection of these personal information like ADHAR No, PAN No, Contact No are delinked from present pension revision work. If need be these information may be collected by CCA office by launching separate drive in which we are ready to extend co operation by publicity.

**Sub: Revision of Pension/Family Pension of pre-2007 retired BSNL pensioners and those who retired between 1.1.2007 and 9.6.2013 with merger of 50% DA amounting to 78.2% IDA as on 1/1/2007 – vide DOT OM No.40-13/2013(PEN T) dated 18/7/2016 issued in compliance to Cabinet Decision dated 5<sup>th</sup> July 2016**

Sir,

Respectfully it is brought to your kind notice that DOT has taken no measure to ensure that the absorbed BSNL pensioners who retired before 10.06.2013 receive the benefit of revised pension at the earliest on implementation of the above stated OM dated 18<sup>th</sup> July 2016 in pursuance to Cabinet decision dated 5<sup>th</sup> July 2016. It has merely issued an Order in a routine manner leaving everything to BSNL and CCA Offices. Our past experience shows that in such an arrangement the pensioners are to wait indefinitely to get the benefit.

2. On acceptance of VII CPC recommendations, the DOP&PW has ordered vide Para 9 of its OM No. 38/37/2016-P&PW(A)(ii) dated 04.08.2016 for adoption of the procedure for revision of pension of the existing pensioners/family Pensioners by authorizing the disbursing authorities including the public sector banks to disburse revised pension without waiting for further authorization from Accounts Officers/ CCAs concerned. Similar procedure was followed while implementing VIth CPC recommendations by Govt. of India in the year 2006.

3. We, fail to understand why DOT cannot follow the same principle for the pre-2007 BSNL pensioners, which has been laid down by DOP&PW for Centrl Govt. Pensioners. This will reduce the volume of work in BSNL Offices for the pensioners retiring between 1/10/2000 1st 31/12/2006, BSNL offices will have to prepare the pension papers/ calculation sheets of only those who retired between 1.1.2007 and 9.6.2013 and send the same to CCA Offices. Thus, both the pre-2007 BSNL pensioners and those who retired between 1.1.2007 and 9.6.2013 will receive the benefit of revised pension early.

4. We, therefore, seek your kind intervention in the matter so that DOT issues an order for revision and payment of pension of the pre-2007 absorbed BSNL pensioners in the same manner as issued by DOP&PW and also advise to BSNL/CCA Offices to arrange early revision of pension of those BSNL pensioners who retired between 1.1.2007 and 9.6.2013.
