Sub: Opening of new CGHS WC in Mansarovar area of Jaipur City (Rajasthan)

Respected Sir,

There is a considerable load on existing CGHS WCs in Jaipur city due to increasing number of beneficiaries. Of late, BSNL Pensioners have also been allowed to join CGHS and due to mass retirement under BSNL VRS, huge number of BSNL retirees has opted for CGHS facility.

Mansarovar Colony at Jaipur happens to be the largest residential colony of Asia spread over in about 6x1.5 Sq. Kms. Most of the population in this colony is of Central Govt. Employees. In fact, some sectors of this colony are exclusively earmarked for Central Govt. Employees. But for availing facilities of CGHS Wellness Centre, they have to travel about 8 to 10 Kms. to the nearest CGHS WC.

It would be in the larger interest of CGHS beneficiaries, if a new Wellness Centre is opened in this colony which will also cater to the needs of surrounding areas, thus help in reducing load on existing WCs.

In this regard, it is reliably learnt that a proposal to open CGHS WC at Mansarovar was under active consideration of the authorities and the decision in this regard is awaited.

Therefore, it is requested to consider the proposal expeditiously and an early approval may kindly be granted to open a new CGHS WC in Mansarovar area of Jaipur City & oblige.
