Sub:- Withdrawal of Lunch Hour Demonstration on 28/9/2011 for expeditious resolution of Pension Revision for pre-2007 retirees from BSNL Corporate Office vide our notice/ letter of even no. dated 29th August 2011

Respected Sir,

A notice for lunch hour demonstration on 28/9/2011 at Sanchar Bhavan followed by DHARNA for two days on 12th and 13th of October 2011 was issued to your office because of the abnormal delay in Pension Revision, and we were constrained to bring to your kind notice that orders for Pension Revision for all the Pre-2007 retirees in BSNL were issued by DOT vide letter no.40-17/2008-Pen(T)-Vol.III dated 15th of March 2011. These orders were further endorsed by BSNL Corporate Office to all the BSNL field units all over India vide BSNL Memo No.40-06/2011-PEN(B) dated 4/4/2011. *It was clearly specified in these orders that Pension Calculation Sheets for all the Pensioners were to be issued before 30th April 2011 and forwarded to respective CCAs for necessary action all over India. It was also specified therein that payment of revised Pension to all the Pensioners/ family Pensioners must be ensured from the month of July 2011 onwards.*

It was also pointed out in our notice dated 29/8/2011 that not a single PPO was revised in case of around 300 pre-2007 retirees from BSNL Corporate Office, New Delhi till 29/8/2011.

We are highly thankful to your good self for your kind intervention in the matter and issue of suitable advice to CMD, BSNL with a copy to Member(F) to accelerate the process of Pension Revision in BSNL / DOT Cell/ CCA Units. After your kind intervention in the matter Pension Calculation Sheets for 195 Pre-2007 retirees were forwarded by BSNL CO in first / second week of September 2011 to PFP Wing of DOT for issue of the PPOs. On 16th September 2011, DDG (Accounts/ TPF) in DOT has deputed two additional officials to expedite the issue of PPOs in PFP Wing. Even though as on date only around 20 PPOs have been issued by PFP Wing, we do hope that the issue of revised PPOs for 195 Pensioners shall be completed by 15th of October 2011 and the same shall be sent to CCA, Delhi for endorsement to respective banks/ Post Offices for payment of revised Pension.

We hereby withdraw our notice dated 29/8/2011 for demonstration on 28/9/2011 and we do hope that PFP Wing in DOT shall complete the issue of PPOs by 15th October 2011 for necessary action by CCA Wing and that CCA Wing will endorse and forward these PPOs by 31st October 2011 to the respective Pension Disbursing Authorities for payment of revised Pension. We do hope that we shall not be compelled to seek your kind intervention once again to expedite this issue.
