Sub: Confusion created on implication of order no BSNL/Admn.1/15-12. Dated 10-6-2020-reg.

Respected Sir,

We would like to draw your kind attention towards the BSNL CO vide the order mentioned under subject has fixed the cutoff date for choosing any of the following three medical options available to pensioners as 30-6-2020.

- a. CGHS
- b. With voucher facility with yearly limit of 15 days pay plus DA
- c. Without voucher with flat ₹1000 per month.

This has created some confusion in the mind of pensioners as below.

- 1) As at present a pensioner can migrate to CGHS any time in a year depending on his affordability as they are to pay the life time contribution for such migration. Whether this option is now withdrawn and no migration to CGHS will be allowed after 30-6-2020?
- 2) As par present practice, option is required to be given only if one wish to change from with voucher to without voucher and vice versa. As per referred order whether all pensioners have to exercise option again afresh or only for change of system option has to be exercised?
- 3) As at present still local train service and metro services are not started. Minimum Busses are playing in the road. Therefore it is extremely difficult for the aged pensioners to visit the concerned office within 30-6-2020 to exercise the option. Kindly extend the cutoff date for exercising option to 31-8-2020.

Finally we also request you to kindly consider our request, to do away the practice of revalidation of BSNLMRS card for current year, made vide our letter of even no dated 02-06-2020.

Kindly examine the points mentioned above and issue necessary clarification early.
