Sub: Payment of long pending medical claims of Pensioners-request for.

Respected Sir,

As you are well aware that the medical claims of BSNL pensioners are waiting for payment since last 2 and half years. Pensioners were also waiting patiently considering the financial constraints of BSNL.

It is learnt that BSNL has made payment for the medical claims of the serving employee's upto march 2020. But the pensioners' long pending medical claims have not been cleared. The pensioners', who have opted CGHS facility one year before their medical claims, have also not been cleared.

In this regard, it is submitted that pensioners have been facing hardship as they have limited resources and they are more susceptible to the diseases due to the age factor. It is also fact that even pension is not sufficient to meet out medical expenses in some metropolitan cities. You are also aware that out of the pending claims, one part is ready for payment and TDS for those are already deducted. Other part is also under process but not entered in the system for payment to avoid TDS deduction. It is expected that BSNL may be financially in better condition after completion of VRS activity and may now take care of its pensioners.

We would, therefore, request you to kindly clear the long pending medical claims for which TDS deductions are made immediately in first phase. In second phase instructions may be given to the field units to process the remaining claims and to enter them in the system for payment. These bills may be cleared in subsequent phases with further improvement of financial status. These pensioners during their service period have served BSNL and now as per assured BSNL MRS they should be given fare treatment.
