- ✓ This GB gracefully acknowledges the contribution of Sri Prahalad Rai towards the cause of the BSNL Pensioners. This GB will also believe that he shall continue his endeavour in this direction in future also.
- ✓ In the Cabinet Note on 78.2% IDA Merger, DOT has proposed to withdraw the 60:40 Pension Sharing systems. If due to any eventuality this method is not withdrawn, this GB requests the CWC of AIBSNLEA to deliberate the course of action in that event for dissolution of this black system which shall definitely endanger the future of BSNL Pensioners.
- ✓ This GB also requests the CWC of AIBSNLEA to deliberate on the automatic Pension Revision system for IDA pensioners like CDA pensioners. It proposes the following for consideration of CWC of AIBSNLEA and if adopted then following it up through Joint Forum for settlement.

1) We should immediately start negotiations with DOT and DPE so that pension revision for IDA pensioners be included in the terms and references of 3rd PRC.

2) Although the recommendations of PRC is only for the executives, but DOT should implement the same recommendations for NON executive IDA pensioners also. ☐

3) In the event of the recommendations of 3rd PRC not implemented for serving executives by BSNL, the pay last drawn at the time of retirement has to be notionally fixed by implementing the latest PRC recommendation and Pension and pensionary benefits has to be calculated as per the revised notional pay. The same process has to be applied for non executives' also. ☐

4) For implementation of the above proposals AIBSNLEA should mobilise the opinion of other Unions/Associations in BSNL and also in MTNL including pensioners Associations.
