Respected Sir,

We would like to bring your kind notice that as per the rules the employees of BSNL can retain his RSTC upto two months from date of retirement and within which the same has to be converted to concessional category. But for the said conversion issuance of PPO is a mandatory requirement.

Now due to present lockdown from 23<sup>rd</sup> March,2020 neither the PPOs are issued nor the employees could complete the formalities for said conversion. As a result the two months grace period has expired for those who retired from 31<sup>st</sup> January, 2020 onwards and now they have started getting telephone bill including rentals like normal customers.

We would, therefore, request your good self to kindly again extend the validity of their RSTC upto 30<sup>th</sup> June 2020 for those who has retired till April 2020.
