Respected Sir,

Kindly refer our earlier letter dated 02-06-2020& 28.6.2020 on above cited subject. We are thankful for extension of the validity of BSNLMRS upto 30-09-2020.


As the prevailing covid-19 situations has not improved rather it has worsened across the country and lockdown is continued in many States and also in containment areas. The services of local trains and metros have not yet started. Ministry of Home advisory suggest the people above 65 years to stay at home. More over after VRS the SSAs are reorganized and now the BSNL administrative offices are located at a distant places.

As a result the pensioners are finding it very difficult to reach to the SSA headquarters for revalidating the BSNLMRS cards.

We would, therefore, request your good self for considering the present abnormal situation of the country, request you again kindly to dispense with the process of revalidation of BSNLMRS cards only for the current year 2020-2021. Let the cards be suo moto revalidated till 31st March 2021. This will extend great relief to the aged pensioners who are really in a distressed condition now. Otherwise kindly extend the last date to 31-12-2020 as has been done for other Medical issues.
