R/Sir,

We are constraint to bring to your kind notice that in the above cited references (3) and (4) DoT and BSNL have issued clarifications that engagement in a CPSE/Govt on contractual/ Consultancy basis would also qualify as reemployment/employment under the DPE guidelines. Whereas, in the terms of clause 8(iii) of BSNL VRS-2019 General Conditions the employee(s) retired under this scheme, shall not be eligible for re-employment in any other CPSE. In this clause no where it has been mentioned that engagement in a CPSE/Govt on contractual/ Consultancy basis would also treated be employment/employment. Thus DoT and BSNL orders under references (3) and (4) are unjustified and arbitrary.

We would, therefore, request your good self to kindly intervene in the matter so that DoT and BSNL letters dated 25th June -2021 and 13 th July-2021 respectively are immediately withdrawn.
