Respected sir,

We regret to mention that the medical claims of BSNL pensioners are not being cleared for the last three years. Whereas, the medical claims of BSNL employees are being paid regularly. This is a great discrimination towards BSNL pensioners who have served DoT and BSNL for their entire service period. We have requested your good self on several occasions in the informal meetings and through our letters and every time you assured to allot some funds to clear the medical claims of BSNL pensioners off-line but despite the assurances no funds have been allotted on this account thus all the medical claims of BSNL pensioners are pending for the last three years. While exercising option for absorption in BSNL BSNL MRS was also one of the consideration to BSNL optees. And now at the fag end of their life this discriminatory treatment is not at all justified.

We would, therefore, earnestly urge upon your good self to kindly intervene in the matter, so that all the long pending medical claims of BSNL pensioners are immediately cleared and these senior citizens are not forced to go on agitation.
