<u>CATEGORY-II</u> --- <u>ELEVEN</u> <u>numbers</u> of private Hospitals / Nursing Homes are neither approved by CGHS nor having the required certificate from Income Tax authority to get exemption from tax liability by BSNL employees. The said Hospitals / Nursing Homes will provide indoor medical treatment under BSNLMR scheme as under:-

- a) To the beneficiaries of <u>SERVING EMPLOYEES ON CREDIT BASIS</u>. The amount paid to the Hospitals / Nursing Homes for this purpose will be considered as perquisites chargeable to income tax & the tax will be deducted from the salary of the employee if applicable.
- b) To the beneficiaries of <u>RETIRED EMPLOYEES ON CASH PAYMENT BASIS</u>. Subsequently the claim should be submitted for reimbursement. The reimbursement will be made as per BSNLMRS rules after deduction of requisite income tax, if applicable.
