Dear Sir,

I Sri Amit Kumar Gupta son of Late Jyotilal Gupta resident of 1/4 Rajendra Banerjee Road, Behala, Calcutta 700034, Telephone number 033 23464646, Mob 9433000088 wish to draw your attention to the fact that the RTI application dated 27-02-2019 has not been replied properly. In the reply dated 16-04-2019 (Received by me on 19-4-2019) in response to points nos 2 to 5, it has been simply informed that "no such information is available in this office".

I have submitted the RTI application for getting the information on whether the Judgement of the Apex Court mentioned in my application has been implemented in BSNL for its pensioners. If information is not available in CO, then it could have been collected from circles or the circles could have been asked to supply the informations sought directly to me, but nothing is done and the responsibility of furnishing the information on this vital issue has been avoided.

Sir, the reality is that the Jusgement has not been implemented in any circles and the applications submitted by pensioners for waiver of the deducted amount in circles are simply lying. The copies of such applications submitted in CO office Establishment section are also perhaps dumped. The pensioners are still suffering and amounts are continued to be deducted at the time of retirement in almost all circles.

I therefore request you to kindly review the issue and kindly instruct to supply information as asked in points 2 to 5., after collecting the same from the circles or the circles may be asked to supply the information as per the provisions of RTI.

I Sri Amit Kumar Gupta son of Late Jyotilal Gupta resident of 1/4 Rajendra Banerjee Road, Behala, Calcutta 700034, Telephone number 033 23464646, Mob 9433000088 wish to seek information as under.

Hon'ble Supreme Court of India vide its judgement on CA 11527 of 2014 delivered on 18-12-2014 observed that recoveries at the time of retirement for following instances would be impermissible in law:

- (i) Recovery from employees belonging to Class-III and Class-IV service (or Group 'C' and Group 'D' service).
- (ii) Recovery from retired employees, or employees who are due to retire within one year, of the order of recovery.
- (iii) Recovery from employees, when the excess payment has been made for a period in excess of five years, before the order of recovery is issued.
- (iv) Recovery in cases where an employee has wrongfully been required to discharge duties of a higher post, and has been paid accordingly, even though he should have rightfully been required to work against an inferior post
- (v) In any other case, where the Court arrives at the conclusion, that recovery if made from the employee, would be iniquitous or harsh or arbitrary to such an extent, as would far outweigh the equitable balance of the employer's right to recover.

Subsequently DOP&T vide no 18/03/2015-Estt (Pay-I) dated 2nd March 2016 (Copy Enclosed) has circulated the judgement for further action

Under this backdrop kindly inform:

- 1) Whether the said order of Supreme Court and the order of DOP&T dated 2-3-2015 has brought to the personal notice of all the officers working in pension cells of various circles and dealing with settlement of pension and pensionary benefits.
- 2) Number of application received by BSNL circle wise so far for waiver of the deducted amount at the time of retirement.
- Number of cases where waiver has been actually ordered so far and deducted amount refunded to pensioners. circle wise.



- 4) Total number of cases circle wise from 2015 to 2018 where deductions have been made from pensionary benefits at the time of retirements for wrong fixation etc.
- 5) Total number of cases circle wise from 2015 to 2018 where pensioner has been asked to deposit some amount as overdrawn amount before settlement of pensionary benefits at the time of retirements for wrong fixation etc.
- I, inform that following formalities have been completed by me
 - a) I have attached the requisite fee of Rs 10/- in form of Postal Order no 07 F 666508
 - b) I am a citizen of India and asking the information as citizen
 - c) I assure that I shall not allow/ cause to use/ pass/share/display/ or circulate the information received in any case and under any circumstances, with any person or in any manner which would be detrimental to the Unity and Sovereignty or against the Interest of India.
