
Subject : Cases of 78.2 % IDA merger from 01.01.2007 and reimbursement of medical bills of Pensioners of W.B.Telecom Circle

This is regarding 78.2% IDA merger from 01.01.2007 and reimbursement of medical bills for pensioners of W.B. Telecom Circle. It has been decided that the following time table will be strictly adhered to by all concerned in order to ensure prompt disposal of all the pending cases.

01. At least 50% pension revision cases of pre-2007 pensioners and 50% pension revision cases of post-2007 pensioners are to be completed and sent to the CCA, DOT-Cell, W.B. Circle, Kolkata latest by 31.10.2016
02. Balance 50% cases of both pre-2007 and post-2007 pensioners are to be completed and sent to the CCA, DOT-Cell, W.B. Circle, Kolkata latest by 15.11.2016.
03. Regarding reimbursement of medical bills it has been decided that all medical bills submitted by pensioners up to 30.09.2016 will be sent for payment through ERP system latest by 15.11.2016.
