SUB:- Provisional Postponement of our scheduled Programme of Protest on 6th April 2016 and 19th April 2016 to HIGHLIGHT the GROSS INJUSTICE & DISCRIMINATION by DoT/ Govt. of India on account of NON-SETTLEMENT of long pending grievances relating to Fifty Percent IDA Merger amounting to 78.2% IDA as on 1/1/2007 granted to BSNL employees/ BSNL Pensioners vide DoT Memo no.61-01/2012-SU dated 10th June 2013.

Respected Sir,

In our unscheduled meeting with your good self on 1/4/2016 in the Visitor's lobby of your office, wherein we requested your good self for early approval of the Cabinet Note for grant of 50% IDA Merger amounting to 78.2% IDA as on 1/1/2007 to the BSNL Pensioners, which was extended to all the BSNL Employees/ Pensioners w.e.f. 10/6/2013 vide DoT Memo no.61-01/2012-SU dated 10th June 2013.

In view of your assurance that you are fully conversant with the 50% IDA Merger and pension revision issue and you are trying to do your best to resolve the issue at the earliest, it has been decided by our Association to defer the scheduled program of protest on 6/4/2016 and 19/4/2016, for the time being.

You are requested to kindly APPROVE THE DRAFT Cabinet Note on this issue submitted to your office on 23rd March 2016 at the earliest for further approval by Hon'ble MOC & IT, and the Union Cabinet,
