Sub:- Prolonged Hold up/ Delay in Pension Revision of around 10,397 BSNL Pensioners retiring before 10/06/2013 after granting benefit of 50% IDA Merger w.e.f. 01/01/2007 vide DOT OM No.40-13/2013-PEN(T) dated 18/07/2016

Respected Madam.

Benefit of 50% IDA Merger was granted to all ex-DOT Employees absorbed in BSNL w.e.f. 1/10/2000, who retired as BSNL Pensioners between 1/10/2000 and 09/06/2013, amounting to 78.2% IDA w.e.f. 01/01/2007 vide DOT OM No.40-13/2013-PEN(T) dated 18/07/2016.

Implementation of DOT OM No.40-13/2013-PEN(T) dated 18/07/2016 should have been completed by 31/12/2016 as per the DOT orders, as communicated in compliance to the Cabinet Note leading to the issue of the order dated 18/7/2016.

It is brought to your kind notice that as on date Pension Revision of 10,397 BSNL Pensioners is still pending with CCA Units of DOT and different Units of BSNL, as per the attached list giving status of Pension Revision as on 31/07/2017 on account of 50% IDA Merger w.e.f. 1/1/2007.

Out of these 10397 cases, the no. of cases pending with CCA Units of DOT are 526 i.e. 205 from Rajasthan CCA, 167 cases in Kerala CCA, 31 cases in Jharkhand CCA, 72 cases in Himachal Pradesh and 44 cases in Delhi CCA.

Similarly on part of BSNL – cases of 7675 Pensioners are yet to be forwarded by BSNL to respective CCA Units for revision of Pension. Also 2196 cases of Pension revision were sent back by respective CCAs to BSNL Units for updation and these need to be immediately sent back to CCAs for Pension Revision.

Circle wise break up for pending cases in BSNL is as follows:- (1) Assam 330 + 10, (2) Chhatisgarh – 101, (3) Delhi – 2067, (4) Gujarat – 81, (5) Haryana – 141, (6) Himachal Pradesh – 120, (7) J&K – 326, (8) Jharkahand- 106 + 36, (9) Karnataka – 0 + 99, (10) Kerala – 312 + 602, (11) Kolkatta Phones – 1279 + 579,(12) MP Circle – 38, (13) Maharashtra – 695, (14) NE-I – 201, (15) Orissa – 395, (16) Punjab – 712, (17) Rajasthan – 155, (18) U.P.(West) – 87, (19) Uttarakhand – 5, (20) West Bengal – 472, and (21) Director(A/C-II) – 52.

You are kindly requested to look into the matter and arrange for early settlement of pension revision for above quoted BSNL Pensioners at the earliest.

Subject: Abnormal delay in settleing the 78.2% Pension revision cases.

Dear Sir,

Kindly find enclosed herewith a status report issued by DOT finance wing on 78.2% pension revision cases as on 31st July 2017 i.e. after one year of the issue of the order. Kindly note that as per the report BSNL circles are yet to send 7675 Service Books to respective CCAs. Also 2196 cases have been referred back to BSNL for wrong calculation etc. That means as per DOT, pension revision cases for about 10,000 pensioners are pending for BSNL. It may also be noted that out of 26 CCAs only 5 CCAs are having some pending cases, remaining have no cases pending with them.

In fields we are experiencing different situation. In the circles where it is mentioned as no pending cases, are actually having many pending cases with them. But the main problem is regarding the figure mentioned as pending with BSNL. This has to be reconciled between the circles and CCAs to identify the cases. For example the figure for Kolkata Phones is shown as 1279 which is pending with BSNL. But the management of CTD is not accepting this figure. According to them maximum 100 cases are pending. Same is the position of other circles. Therefore it is absolutely necessary that reconciliation of these pending cases is done between BSNL and DOT to identify the cases. The most unfortunate point is neither BSNL circles nor CCAs are having any comprehensive list and details of pensioners in most of the circles. As a result they are unable to locate the pensioners whose pension is not revised.

All CCAs are supposed to have the list of pensioners/ Family pensioners coming under purview of the present 78.2 pension revision. We therefore request you to kindly issue necessary instructions to all CCAs, so that the pensioners whose pension is not revised are identified and intimated to respective CGMs of BSNL. Their details may be circulated in respective websites also for information of all
