Sub: Subject:- Revision of pension of BSNL & MTNL pensioners w.e.f.1-1-2017 by delinking from pay revision of BSNL/MTNL employees-Reg:

Hon'ble Sir,

We are extremely thankful to your goodself and grateful for the decision of pension revision of BSNL/MTNL pensioners by delinking from pay revision of BSNL/MTNL employees w.e.f. 1-1-2017.

After your kind consideration and direction the DoT administration has proposed for pension revision of BSNL/MTNL pensioners wef 1-1-2017 by delinking pension revision from pay revision of BSNL/MTNL employees and to give notional fixation of pension revision of BSNL/MTNL pensioners who will be retiring after 1-1-2017. But, DoT has proposed to give 0% fitment benefit to BSNL and MTNL pensioners wef 1-1-2017 which is not justified. The 0% fitment benefit is only 100% IDA neutralization with basic pay, but, not pension revision or pay revision. BSNL/MTNL pensioners are the Government pensioners and drawing pension from the Consolidated funds of Govt of India at par with other Government pensioners under Rule 37-A and CCS Pension Rules 1972. Thus, the pension revision of BSNL/MTNL pensioners should be revised as per the recommendations of 7th CPC pension revision fitment formula. 3rd PRC recommendations don't have any recommendations for pension revision of PESB employees. Thus, the pension revision of BSNL/MTNL pensioners is justified at par with the other Government pensioners as per the recommendations of 7th CPC fitment formula.

We would therefore request your kind honor to kindly intervene in the matter so that the revised proposal for pension revision of BSNL/MTNL pensioners is prepared as per the recommendations of 7th CPC fitment formula.
