SUB : Overstay period of patient in the hospital in excess of days prescribed in package rate in respect of indoor medical treatment under BSNLMRS on credit basis.

As per CGHS office memorandum No. 2-1/2012/CGHS/VC/CGHS(P) dated 01.08.2013, maximum duration of indoor treatment is 12 (Twelve) days even for super specialties treatment. BSNL Corporate Office letter No. BSNL/Admn.I/15-7/12 (pt.) dated 04.04.2012 also stipulates that the over stay period is to be decided following CGHS guidelines. It is accordingly decided to extend the credit facilities to BSNLMRS beneficiaries for 12 (Twelve) days in maximum. As per agreement made with the empanelled Hospitals / Nursing Homes for indoor medical treatment under BSNLMRS on credit basis, normal treatment period is 7 (Seven) days or the patient becomes stable whichever is earlier. Continuation of treatment beyond 7 (seven) days and upto 12 (Twelve) days if needed may be decided by CTD/BSNL authority on getting a report from the Hospitals / Nursing Homes.

The Hospitals / Nursing Homes authority must obtain a written approval of CTD/BSNL if the patient is required to stay beyond 7 (Seven) and upto 12 (Twelve) days with proper justification of further indoor treatment.

Beyond 12 (Twelve) days, if additional stay in the Hospitals / Nursing Homes is required for treatment, the charges for additional period is to be paid to the Hospitals / Nursing Homes by the beneficiary. The beneficiary may claim reimbursement of this amount later on. The said reimbursement claim will be settled as per existing guidelines of BSNLMRS on cash payment basis indoor medical treatment.

This circular shall be effective on and from 01-09-2017.
